TO: All Programs of All Inclusive Care for the Elderly (PACE) Organizations
FROM: Health Outcomes Survey—Modified (HOS-M) Project Team
DATE: February 28, 2022
RE: Medicare Health Outcomes Survey—Modified 2022 Administration

The Centers for Medicare & Medicaid Services (CMS) has contracted with the National Committee for Quality Assurance (NCQA) to oversee the administration of the HOS-M for PACE organizations. CMS has also contracted with RTI International (RTI) to provide additional survey support in the administration of HOS-M, as well as data analysis.

The HOS-M is an abbreviated version of the Medicare Health Outcomes Survey (HOS), which CMS uses to assess participant physical and mental health functioning. CMS uses the HOS-M to evaluate program participants using limitations on activities of daily living (ADL) to generate information for frailty payment adjustment.

This memo includes the information PACE organizations need in order to comply with HOS-M 2022 reporting requirements. CMS will post this memo on the <u>HOS website</u> (http://hosonline.org/). This document is organized as follows:

#### HOS-M 2022 Survey Administration Memo Changes

#### **Reporting Requirements**

All PACE organizations with Medicare contracts in effect on or before January 1, 2021, and with enrollment of at least 30 beneficiaries as of February 2022, are required to administer the HOS-M in 2022.

#### NEW: Notifying the NCQA HOS-M Project Team of Survey Vendor Selection

All PACE organizations must report their survey vendor selections to NCQA using the <u>HOS-M</u> <u>survey vendor selection web form</u> (https://www.ncqa.org/hedis/measures/hos/m-survey-vendor-selection-form/) no later than Friday, April 15, 2022.

The web form must be completed entirely and must include the following information:

- Primary contact person (name, telephone number, and email address).
- PACE organization contract number and name.
- Name of HOS-M survey vendor.<sup>1</sup>

#### Contracting with a CMS-Approved Survey Vendor

This year, there are two (2) CMS-approved HOS-M survey vendors that PACE organizations may contract with to administer the HOS-M survey. CMS annually trains and approves survey vendors to administer the HOS-M survey on behalf of PACE organizations.

When contracting with an HOS-M survey vendor, please keep in mind that PACE organizations must cover the cost of survey administration.

The following survey vendors are conditionally-approved by CMS to administer the 2022 HOS-M:

- 1. Center for the Study of Services (CSS)
- 2. DataStat, Inc.

Attachment 2 of this memo lists contact information for the conditionally-approved HOS-M survey vendors. PACE organizations are required to contract with a CMS-approved survey vendor. CMS encourages PACE organizations to work with their survey vendor to understand the survey administration and data submission timelines. To ensure the confidentiality of the survey process, survey vendors are prohibited from providing PACE organizations with patient-level data or reports during any phase of the data collection period or between each annual HOS-M survey administration.

The NCQA HOS-M Project Team closely monitors survey vendor performance as the survey progresses by reviewing survey vendor mailing materials and telephone scripts, requiring survey vendor progress reports, monitoring telephone interviewing, and performing site visits. The

NCQA HOS-M Project Team also assesses survey vendor performance against both the 2022 *Medicare Health Outcomes Survey Quality Assurance Guidelines and Technical Specifications V2.6* (HOS QAG), the HOS-M QAG Addendum, and the survey vendor Quality Assurance Plan (QAP). The QAP documents all systems survey vendors use to implement HOS-M.

#### **Survey Administration**

The HOS-M will be administered from late July through November 2022. The questionnaire is available in English, Spanish, Chinese, and Russian. PACE organizations, depending on the size of their enrollment, will be required to provide information prior to survey administration, including contact information for each participant and up to two of their family contacts or other caregiver contacts.

CMS provides the HOS-M survey in English, Spanish, Chinese, and Russian to facilitate the participation of the broadest pool of plan members and promote accurate measurement of the experience of Medicare beneficiaries enrolled in PACE organizations. Collecting information from beneficiaries who can only respond to the survey in Spanish, Chinese, or Russian increases the usefulness of the HOS-M for quality improvement initiatives.

PACE organizations should notify their survey vendor of any additional language translations needed for the HOS-M. CMS will consider these translation requests for implementation in future survey years.

RTI will draw the sample for 2022 HOS-M. To develop the sample, RTI works with PACE organizations to verify mailing and enrollment information for program enrollees and to collect data for potential survey proxies. PACE organizations should submit this information to RTI no later than April 22, 2022. RTI will hold an orientation webinar with programs on March 14, 2022, to provide an overview of the 2022 survey administration process. Programs will receive information directly from RTI about the webinar.

#### **Sampling Process**

The sample size for 2022 survey administration will be 1,200 for PACE organizations with at least 1,200 participants. For smaller PACE organizations, the entire eligible enrollment is included.

Programs with populations of ≥1,200 participants	One thousand two-hundred eligible program participants are randomly selected for HOS-M. PACE organizations provide a list of members who have become permanent nursing home residents, who will be excluded from the survey process. PACE organizations append telephone numbers for each selected member to a file provided by the survey vendor.
Programs with populations of <1,200 participants	All eligible participants are included in the sample. PACE organizations create a detailed contact list for all eligible participants.
